PURCHASER AGREES TO THE FOLLOWING:

1. Under no circumstances will this cat or kitten be sold, leased or given away, or sold to any pet shop, research laboratory or similar facility.
2. This cat or kitten will be kept indoors and not be allowed to roam freely outside, nor will this cat be declawed without contacting breeder for permission.
3. This cat or kitten is purchased for the purpose of: Pet ____ Breeder ____ Show ____
4. If this cat or kitten is found to be neglected or mistreated, Purchaser will surrender said kitten or cat to Seller, unconditionally.
5. This kitten will be the recipient of much tender loving care, will be fed the best possible diet, will receive lots of entertainment and will be treated with greatest respect so that she/he will reach it's potential..
6. If purchased as a pet, Purchaser agrees to castrate or spay this kitten between the ages of 3 and 6 months and guarantees that this cat or kitten will NOT be used for stud or breeding. Failure of the buyer to provide proof of spay or neuter within this time line will result in the buyer paying full breeder price for the cat or kitten.
7. Seller agrees to provide pedigree and registration papers upon proof of spay or neuter
8. No cash refunds will be issued for the purchase of this cat. Deposit of \$100.00 for pet and \$250.00 for breeder/show cat is non-refundable once you pick your cat or . kitten. However, if the purchaser backs out of the sale at the last minute for a cat that has been paid in full, the seller will refund the purchase price minus \$200 for the loss of the sale. After that time the seller will take the kitten back at any time provided it is in good health, but with NO REFUND of purchase price.

10. This cat or kitten is being fed: Royal Canin kitten dry food free choice with added cooked chicken & canned food twice a day. Sample of food to be provided
11. Micro chip will be in place when kitten is adopted and appropriate registration information provided.

ADDITIONAL TERMS AND CONDITIONS:

HEALTH GUARANTEE:

This kitten is guaranteed to be of sound health upon arrival. It is guaranteed for a period of 72 hours from time of arrival, if vet-checked within that time. It is recommended that the new kitten be in quarantine during this time. If it is found to be medically deficient with an untreatable or life-threatening problem, it must be reported to the seller immediately. Upon its return, it will be replaced with another kitten of equal value. If no replacement is available at that time, seller will have 6 months to furnish satisfactory replacement. The kitten cannot be returned after the guarantee period has expired and/or if it has been exposed to another cat, which has not been currently tested for FELV and FIV. It is the responsibility of the buyer to provide immediate veterinary care to any cat/kitten showing signs of illness or distress and failure to do so will render any guarantee null and void. Under no circumstances is a kitten to be destroyed prior to notification by the buyer to the Seller.

This kitten is guaranteed against congenital defects for 6 months. Should the cat die within that time as direct result of a congenital defect, the cat will be replaced ONLY if a licensed vet performs an appropriate autopsy and a vet's certificate is provided as proof of cause of death. A replacement will be made of a cat of comparable quality and value, as available, at the discretion of the breeder.

This contract is legally binding to all parties involved. It applies only to the buyer and seller in this transaction and is non-transferable to other parties. There are no other conditions or guarantees, whether verbal or implied. Purchaser's signature indicates full understanding of contract and agrees to the terms in this contract.
